Dear LWYC Board Officers:

As a proprietary Club member and shareholder since 2012, I am formally requestir inspect LWYC records relating to the August 14, 2016 suspension of proprietary cl member Sandi Scull.

At the Club's annual meeting in August 21, 2016, I proposed a motion to withdraw suspension until such time as Sandi was afforded the due process required by the bylaws, including notice and an opportunity to be heard. At that time, I was advise President Fedak that my motion was new business, and the Board did not entertai business at the annual meeting. I was told I should reintroduce the motion at the next meeting, which according to the Club's webpage has been rescheduled for Fr September 23, 2016 at 7:30 phttp://lwyclub.com/bod-meeting-rescheduled/

I intend to appear at the September Board meeting both to renew my motion and t on member Sandi Scull's behalf in opposition to her recent suspension. Pursuant t relevant Pennsylvania statutes governing nonprofit club**B**a**1**5.S.A¤5508(b), I request to inspect and copy the Club's records relating to the both the process by she was suspended and the substance of the seven disciplinary infractions set for Board's August 14, 2016 letter announcing her suspension.

<u>Due Process Concerns Records Inspe</u>ction

I request to inspect any documents, including emails, showing Sandi was given 1€ notice of pending disciplinary action relating to the seven infractions prior to her At 14, 2016 suspension. I further request to inspect any document showing she was an opportunity to appear before the Board to be heard on the 7 infractions spelled the August 14 suspension letter. I also request to inspect both the Club's liquor lice and the Club's articles of incorporation, which I believe the Club is required to mair on the premises and make available for inspection by state liquor authorities. PAL Control Board Code, 40 Pa. Code ¤¤5.71 – 5.75.

Disciplinary Infractions Records Inspection

I also request to inspect records, including emails, relating to the following 7 discipl infractions upon which the Board based its August 14 suspension.

1. Failing to inform the Board and others about PA liquor license operating requirer

I request to inspect any documents relating to Sandi's alleged failure to inform the I of a PA Liquor Control Board ("LCB") requirement that nonprofit licensees remain ● at least one day in every 15-day period or turn their liquor license in for safekeeping Liquor Control Board Code, 40 Pa. Code ¤7.31.

As part of this request, I seek to inspect any Club records of audits that the LCB conducted of the Club's operations. As compliance audits usually address complia with applicable standards, the audit files may well disclose that the Club and the Bc had knowledge about the LCB's 15-day rule. Any such audit files, including an LCE audit reportedly conducted around 2007, should be in the current Board Secretary's possession.

2. Refusal to pay \$21 outstanding fee for replacement key I request to inspect any documents relating to the \$21 bill to Sandi Scull for the post office key.

3. Inaccurate reporting of the club's minutes (resulting in her removal as club secretary)

I request to inspect the club minutes which she allegedly inaccurately reported.

4. Altering the club's House and Grounds Rules for the Club yearbook regarding sleeping overnight at the dock

I request to inspect the Club's House and Grounds Rules that were allegedly altere Sandi.

5. Withholding funds for the sale of the club's burgees

I request to inspect any documents showing Sandi withheld funds for the sale of the club's burgees. If there are no documents, please provide the names of the persor information the Board relied upon in deciding to suspend Sandi for this alleged con 6. Repeatedly putting her own interests and agenda first and not the Club's interest I request to inspect any documents relevant to the allegation that Sandi repeatedly own interests and agenda first and not the club's interests, including any document relating to the example cited in the Board's August 14, 2016 letter that (1) Sandi had informed the BOD that the club had a no wake buoy permit, and (2) that Sandi had renewed a wake buoy permit because she believed it would interfere with her sailir

there are no documents, please provide the names of the persons whose informati Board relied upon in deciding to suspend Sandi for this alleged conduct.

7. Continually fueling an atmosphere of dissent and divide of sailors against the re the club

I request to inspect any documents relevant to the allegation that Sandi continually fueled an atmosphere of dissent and divide of sailors against the rest of the club. If there are no documents, please provide the names of the persons whose information the Board relied upon in deciding to suspend Sandi for this alleged conduct.

Sandi created a club within a club when she allowed the handicap racers to collect money and create their own treasury under the LWYC name. When confronted with this at the annual meeting she told the board it was none of their business.

She is a person who told a prospective club member why would you want to join this club. Bob Schaffer.

She is a person who finds fault with the food that is prepared by club members by saying who would cat that stuff.

Sandi feels that the sunfish class if it had continued should be given by someone that is certified. Having 47 students over the four years for only 10 hrs a summer we feel we did a great job.

She is a person who never pays her dues on time. Due date is March 1st. Yet she still has full privileges. Is this fair to the rest of the membership?

She is a person who at the 2002 Governors cup regatta asked sailboat owners who have slips if some of the contestants could sleep on their boats. This is against lake rules and LWYC rules.

As beach master during another Governors cup regatta the lake was very high, she had the sailing docks pulled in but did not pull in the slip docks. In the afternoon a club member was coming down the ramp off the slip dock when he slipped and fell.

The incident with the cabinet door and lock being ripped off, again shows that she has no regard for the club or its leadership.

If you take a close look at all the above you can see that Sandi bends the rules and regulations for her best interest but not that of LWYC. If we all had this attitude where would this club be. We feel that the board should take appropriate action in this matter.

Dear LWYC Board Members,

We were approached by Elaine Dwyre if we would be willing to give sunfish lessons to her and her granddaughters. Heinz and I decided that we would. A date was set for Monday afternoons the months of July and August.

The class consisted of Elaine (her granddaughters), John Fasano (his granddaughters are planning on coming later in the summer), Rob Price (Heinz's crew), RJ (our neighbor), Heinz and myself.

The board meeting of Friday June 27, 2003 I informed the board that we were planning on giving these lessons with the help of those involved. A motion was made and carried. Brian Williams said he was glad that we were giving the lessons again. John Weiss came up to me at another time and said he wishes his son could join us.

Our first lesson was on July 7th. The children and adults had a great time. Everyone went home with a feeling of accomplishment especially the children. The three children took turns with Heinz on our sunfish, I was with Elaine on her sunfish and John and Rob used the club sunfish.

The second class was scheduled for July 14. When we arrived we noticed the club sunfish was gone along with the rigging. Thinking that some one was using it we did the best we could with only two boats.

We could not understand who would take the boat for that length of time. I asked Elaine when she talked to Sandi on Saturday if she mentioned the sailing lessons. She said yes.

Bill Vande Vaarst was notified by John Fasano that the boat was missing. Bill than made calls to find out where it was. The boat was taken by Sandi Scull over to Bob Ross for whatever reason. The sunfish was not on the beach for about six or seven days.

In the past year Sandi has had confrontations with our past president/commodore Al Kelly where she refused to give him a financial accounting of the Governors Cup Regatta (2002). This was witnessed by a club member. (John Fasano) The removal of the cabinet door from the frame to get the flags (which was not necessary as the fleet does not use these flags in regular Saturday racing and it was also raining that day). There were witnesses to this action. (H&G #2) This is one of the major reasons why we lost Al and Barbara Kelly as members who only had the best interest of our club at heart. (Al Kelly)

These are on going violations of our house and ground rules and it is time the board realizes that and takes immediate and appropriate action to have Sandi Scull suspended from the club.
