2019 LWYC Annual Report

Committee/Office: Budget and Finance

Chairman: Lynn Cunningham

I am pleased to report that both insurance policies are still intact. Our Marine Insurance is held by Smithwick Mariners and our Directors and Officers insurance is held by Sheeley Insurance Agency.

The 2019 operating budget was presented to the Board of Directors on March 8, 2019. At that meeting, it was determined that we were in adequate financial shape to continue with small interior and exterior improvements. A sizeable portion of funds was allocated for dock flotation replacement and dock repair. The budget also reflected the need to upgrade our air conditioning system.

At the beginning of June, the flexible CD (0.4% interest rate) that was held at HNB was rolled into a fixed 11-month CD at a 2.37% rate. If there is need to access the CD during the 11-month period, the penalty would be deducted from the interest earned. There would be no loss of principal.

I will continue to use Quick Books software to prepare budgets so that we can use previous year comparisons to accurately predict routine expenses.

Sailing activity- A total of 4 Lightnings participated in racing this year, Bob Hall having to take a hiatus for personal reasons. Complete final results will be compiled for posting on the website. The season results, revealed at today's picnic are: George Madel won the Folwell and the Miller Series; Peter Seeuwen won the Baron and the Overall 2019 Championship.

On August 3, the fleet and many former fleet members gathered to help George Madel celebrate a milestone birthday (90) w/ an ice cream sundae event. George continues to beat us on the course with no plans to quit. Congrats, George.

If the rest of this report sounds a lot like last year's, it is because the same concerns and items still need to be addressed.

MAJOR AND CAPITAL EXPENDITURES:

Peter & Stef made repairs to hoist motor again. It is working, for now. Please remind Skane to take it down when he pulls docks and hang it in the spring. We have no safe way to reach the boom.

The Miller trophy will be retired this year. A new trophy/name for this Series will be in place for next season. It is anticipated that the club will help finance the new trophy expense.

Repeat- Docks- We recommend that as new top boards are installed that new rubber edge guards be installed that will last longer and look much better.

Cleats need to be re-installed as well at that time. This committee requests that All decisions regarding the sailing dock include the committee in those discussions. We know better what the functional needs are and want input into all decisions.

INCOMPLETE OR UNRESOLVED ISSUES:

Fleet 16 End of year picnic and Awards ceremony was Aug 24th. Yesterday. Thank you for not scheduling another event of this day this year.

Again- Since the fleet was evicted from the sail loft (garage), it has become a dumping ground for junk and others' cast offs. I concur with John Cope that the conditions here are unacceptable. The pile of old inflatables has still not been disposed of. Please either sell, give away or trash, or give us the OK to do so.

Also, we have had to climb over lumber to get to the sail racks. It doesn't belong there. Page 2 2019 Annual Report- Sailing & Regatta Committee report

The board, in evicting the fleet, passes up \$450 each year in unencumbered income for the club that can be used to help put the rubber rails on the sailing dock and finish dock restorations. All to store other people's stuff for free all winter. Ahem.

A new problem arose today- one rail of the dolly system has been damaged, breaking a weld point in the rail. We jury-rigged a temporary fix to race, but we need a welder to make permanent, effective repairs. The waterline should be low enough within the next 2 weeks to do so. Also, some repair welding has been needed on the actual dolly, which can be done at the same time. Currently, the rail track is not usable. The gravel dune on the beach has to be removed, re-spread where it was originally. It has buried the track all season, making it occasionally impossible to launch boats.

GOALS FOR 2019:

We have had several offers and opportunities to provide small sailboats (Sunfish, Lasers, etc.) for general use by club members. With boats, we can then work w/ the

Membership Secretary to identify youth members/ages within the club to determine viability of a junior sailing program. There seem to be a lot of them. We also have access to a number of resources through US Sailing that go untapped.
