

### MEMBERSHIP DUES/COSTS:

Your Membership dues are due on or before March 1, for the season. If your Membership fees are not paid by March 31 your membership will be terminated.

#### WORK DAYS:

**Club Work Days** are **MANDATORY** for all Associate and Proprietary Members under the age of 70. <u>Missed Club Work Days will be charged a fee of \$200.</u>

**Dock Work Days** are **MANDATORY** for all dock holders. <u>Missed Dock Work Days will be charged a fee of \$200.</u>

**Club Work Days** and **Dock Work Day** dates are communicated within a reasonable amount of lead time via email notification. It is **YOUR** responsibility to make other arrangements with the COMMODORE if you are unable to attend one or more of the scheduled days.

If fees for work days or food minimums are not current, your club privileges will be suspended until brought current.
